

Letter from the President

The year 2023 has seen a stratification of ongoing crises in which the continuing war between Russia and Ukraine has been joined by a new and violent outbreak of the Israeli-Palestinian conflict. The effects of these crises heavily felt from an economic and social point of view in Europe and more than ever in Italy. Moreover, due to the increase in the number of countries affected by wars, famines and natural disasters caused by severe climate change impacts, the migration of populations fleeing these countries and seeking safer places to live has increased sharply.

In Italy, policies to mitigate and manage this phenomenon in a humane and respectful manner are still far from being implemented, and the current Italian government, besides absurd repressive policies and migrant refoulement, has launched the 'Piano Mattei' as part of its migration strategy, with the immediate consequence that all the funding directed to the few priority countries in Asia such as Myanmar have been redirected to African countries.

Unfortunately, other Italian institutional donors were forced to adapt to this policy, drastically reducing the possible sources of funding to countries where ASIA has been working for more than 30 years.

This situation led to a drastic decrease in funding retrieved during 2023 and to fewer new projects being financed, of which there were only 9 across 2023. Thanks to the residual income from 2022, along with new funding, 23 projects were implemented in 2023, of which 9 were completed and 14 are still ongoing with expected closure in 2024.

We worked in Myanmar, Nepal, Bhutan, Mongolia and Italy reaching a total of 14.755 direct beneficiaries and 56.872 indirect beneficiaries.

The priority areas of intervention were: food security, agriculture and pastoralism with 9 projects; global citizenship education with 4 projects; cultural heritage protection with 3 projects; education with 2 projects, emergency with 2 projects, WASH with 2 projects and environmental protection with 1 project.

We pledged to contribute to the Sustainable Development Goals to develop ecologically sustainable and organic agriculture to combat the impacts of climate change; to improve access to education through long-distance sponsorships, teacher training and support for schools in remote areas; to defend the cultural, spiritual and linguistic heritage of oppressed cultural minorities; to educate and raise awareness in civil society on the issues of climate change, solidarity, human rights and fundamental freedoms, the dignity of every person, introducing Buddhist cultural values such as empathy, non-violence and interdependence to create a more respectful and tolerant society. In all the projects implemented, we have given careful attention to women's participation in order to achieve gender equality by strengthening women's access to education, training and employment.

In Nepal, despite its great cultural heritage and diversity, is one of the poorest countries in the world, and in the last three decades has suffered the blows of a civil war, two devastating earthquakes and the covid-19 pandemic, which have further slowed down its development and caused very high emigration rates. We have been operating in this country for almost 27 years and during 2023 we reached about 3,000 direct beneficiaries. A total of 10 projects were implemented: 2 to protect Tibetan cultural heritage; 4 to ensure food security; 1 to protect the environment; 1 for emergency relief following the earthquake in the Karnali province; 2 to ensure the availability of potable water and improve sanitary conditions in rural areas.

Bhutan, the only country in the world with a Vajrayana Buddhist tradition, is known for its efforts to protect its ancient culture and biodiversity from exploitation and globalisation. In truth, Bhutan, too, has suffered dramatic impacts since opening up to the outside world, putting its cultural heritage, pristine natural environment and biodiversity at serious risk. In the remote areas, unfortunately, income opportunities are very limited and the local people, mostly farmers or nomads, live off their own agricultural products which, more often than not, are not sufficient to guarantee food security or economic self-sufficiency. ASIA has been working in this country since 2019 and in 2023 we implemented 4 projects, including 1 to protect cultural heritage, 2 to ensure food security in very poor districts and 1 to improve the quality of education in schools located in remote areas. In 2023, 2,187 people directly benefited from these activities.

In recent years Myanmar has been facing a number of health, economic and political challenges that have undermined its stability and economy. The COVID pandemic has strained the country's health and economic system, with a huge impact on the tourism and export sector. The military coup enacted by the Burmese armed forces on the morning of 1 February 2021 started fierce clashes that are now widespread throughout the country, now considered one of the most dangerous in the world by UN reports. During 2023, the sectors of intervention in which ASIA worked were emergency, food security and agriculture, managing to support 5560 direct beneficiaries.

Mongolia, a country known for its rich nomadic culture and millenary traditions unfortunately remains outside the interests of international cooperation. Although life in the capital, which is home to about a third of the total population, now fairly adapts to Western standards, the rest of the population lives according to nomadic traditions in wastelands or concentrated in the gher, an area just outside Ulan Bator, in very precarious social, economic, and sanitary conditions. In this context, and despite a small setback due to COVID-19, ASIA has maintained its presence with international staff since 2016 and has continued to support the population with projects focused especially on the education and pastoral sectors. In 2023, ASIA implemented one project in the education sector and reached 1,323 direct beneficiaries.

In Italy, 2023 started with the last activity of the project 'Educating to defend animal rights and protect the environment for a sustainable future of planet Earth', the webinar 'Animal Landscapes. The human-animal relationship between history, environment, psychology and religion", which was attended by well-known speakers and experts in their respective disciplines and a very interested audience. During the year, we concluded the project 'Let's Make Peace. Taking care of one's inner enemies to make peace with the outside world' - focused on awareness and making peace with one's inner world as a necessary condition for establishing relationships based on respect, listening and empathy - and we started a new project 'We are One. From the illusion of a separate self to the awareness of an interconnected self', which aims to alleviate the sense of separation and isolation widespread among young people, providing useful tools to develop a more empathic and connected self with others and with the environment.

Finally, we continued the activities of 'Green school Italy: network of schools and territories for sustainable development' through which an increasing number of schools are acquiring the tools to apply good practices in the direction of environmental sustainability and the fight against the impacts of climate change. Throughout 2023, we reached 2,188 people directly.

Our Annual Report for 2023 provides precise data and information related to all the activities mentioned in this letter, supported by indicators used by ASIA to measure results. Every year we try to improve its contents to provide more information to communicate how the funds that we receive are invested; the number of beneficiaries reached and the impact we have had in the areas where we operate. Finally, we would like to highlight our small contribution to achieving the sustainable development goals of the 2030 Agenda.

Everything we have been able to achieve, despite increasing difficulties, has been possible thanks to our donors, supporters who have been following us for so many years, partners, the board of directors and our staff in Italy and in the countries where we operate. We remain hopeful that we will continue to pursue our mission and contribute actively to alleviating suffering and poverty and creating a more just, sustainable and war-free world.

Methodological Note

ASIA, with this document, intends to offer all interested persons, supporters, donors, collaborators, partners and civil society, in a clear and transparent manner, all the relevant information about the activities carried out, the results achieved and how funds were spent throughout 2023 to achieve the objectives set out in the organisation's strategic plan.

The current document consists of four chapters divided as follows:

The first chapter provides information about ASIA, its offices in Italy and around the world, the acknowledgments received over the years, its history, the values it is inspired by, the countries where it operates, the vision, the mission, the organisation's governing bodies, the organisational chart, and the personnel.

The second chapter briefly illustrates the collaborations and synergies that make ASIA's projects possible: the donors to whom the association has turned to for funding and support, the partners with whom ASIA collaborates in the various countries of intervention, and the networks of which ASIA is a member.

The third chapter describes the organisation's ethics with the codes, policies and procedures that govern ASIA's activities and the behaviour of personnel involved in the activities. It then describes the project proposals that were submitted, those that were approved, to which donors they were sent, the amounts financed, and the countries and sectors of intervention of the projects approved and implemented throughout the year. Moreover, it provides a brief outline of the contribution made to achieving the 2030 Agenda for Sustainable Development and the beneficiaries reached in the various countries of intervention. Finally, the projects implemented during 2023 are presented, organised by country of intervention (Bhutan, Nepal, Myanmar, Mongolia and Italy), providing all the necessary data: objectives, activities, results, outputs, beneficiaries reached, donors and funding spent during the year. The long distance sponsorship project activities are then described, with a quantitative analysis of the results achieved during the year in terms of support; the critical issues and problems encountered and a description of ongoing projects by country. At the end of this chapter, fundraising and communication activities

are mentioned, describing the events organised during the year, campaigns, solidarity gifts, and communication activities.

The fourth chapter contains the economic balance sheet for 2023 with balance sheet and profit and loss account, with income and expenditure during the year. This is followed by the mission report with the new reclassification of the balance sheet prepared according to the criteria issued by the Ministry of Labour. The main items are: fixed assets, current assets, accrued income and prepaid expenses, shareholders' equity, provisions for commitments and risks, and payables. The full report of the audit carried out by an independent auditor is then included. The chapter concludes with the full report of the Monocratic Auditing Body. All data in the document was subject to analysis and control by ASIA's internal audit and verification processes.

The social report is available in a digital version in Italian and English on the ASIA website and is printed in very few copies in Italian and English to reduce expenses and the use of paper, in order to protect forests and the environment.

ASIA – Association for International Solidarity in Asia – was founded in 1988 by Chögyal Namkhai Norbu, a profound connoisseur of ancient Tibetan culture and history and Master of the Dzogchen Teaching.



It is a Non-Governmental Organisation (NGO) accredited by the Italian Agency for the Cooperation and Development (AICS) and an ETS - Third Sector organisation - registered at RUNTS (Single National Register of the Third Sector).

ASIA operates in the Asian continent - specifically in India, Nepal, Mongolia, Myanmar and Bhutan - and in Italy.

Throughout all these years it has helped more than 1.500.000 people.

In addition to having acquired professionalism and experience in the management of development and emergency projects, ASIA and all its staff in Italy and around the world have absorbed and made their own the values encountered in many of these ancient cultures. Values such as awareness, compassion, altruism, openness to different cultures, and direct involvement with local communities, have become an integral part of ASIA's work.

The objective of our Association is not only to fight poverty but to create a culture of peace and tolerance to participate in the creation of a better society, respectful of individuals and the environment in which they live.

Chögyal Namkhai Norbu

(1938-2018)


Renowned scholar of ancient culture and history of Tibet, holder of the knowledge of the Dzogchen Teaching and spiritual Master, Chögyal Namkhai Norbu was born in 1938 in Derge County, in the Tibetan region of Kham, in Eastern Tibet. Following the completion of his studies in philosophy and literature, he was invited to Italy in 1960 by the renowned Tibetologist and Orientalist Giuseppe Tucci, to catalogue the Tibetan texts preserved at ISMEO (Institute for the Middle and the Far East). In 1962 he became professor of Tibetan and Mongolian language and literature at the University of Naples 'L'Orientale', where he taught until 1992.

Chögyal Namkhai Norbu dedicated his life to making the vast cultural and spiritual heritage of Tibet known and to pass it on to future generations.

In 1981 he founded Merigar, the first centre of the International Dzogchen Community, from which similar centres have subsequently sprung up in other European countries, in the United States, South America, China, Russia, and Australia; giving rise to the present International Dzogchen Community International. In 1988 he founded ASIA, with the mission of safeguarding the cultural and spiritual identity of the Tibetan people and to improve the living conditions of the populations of the Himalayan area.

Chögyal Namkhai Norbu's commitment to studying and preserving Tibetan culture was unceasing. In particular, his contributions concern the ancient history of Tibet, the indigenous pre-Buddhist traditions, customs of the nomads, the origin, theory and practice of Yantra Yoga, astrology and traditional Tibetan medicine.

For his extensive cultural activities and tireless social engagement, he received countless awards and honours. Among these, the honour of "Commendatore al Merito della Repubblica Italiana" received from President Sergio Mattarella in 2018, deserves a special mention. Chögyal Namkhai Norbu passed away peacefully at his residence in Gadeling, in Arcidosso (GR) on 27 September 2018.



Our History



1988

Chögyal Namkhai Norbu founds ASIA after a series of missions in India, Nepal and Tibet, during which he verifies the difficult cultural, social and economic conditions of the Tibetan population.

1989

Projects focus on improving the living conditions of Tibetan refugees in India. The 'A New Tibetan Village' project begins.



The first mission to China was carried out to negotiate permission to enter Tibet to assess needs and present the first projects to institutional donors.

1993

The construction of the first Tibetan school, built by ASIA in Dongche, Qinghai Province (formerly the Tibetan region of Amdo), begins.

With the guidance of Chögyal Namkhai Norbu, the first mission to Tibet is carried out, to visit the eastern, central and northern regions.



1994

The long-distance sponsorship project in India and Nepal is launched.



1996

The implementation of the Gamthog health and education project in Eastern Tibet, funded by the Italian Ministry of Foreign Affairs, begins.

1997

Chögyal Namkhai Norbu travels to Tibet for the last time to inaugurate the Dongche school.

ASIA intervenes in the prefectures of Ngari in Western Tibet and Yushu Prefecture in Eastern Tibet, hit by devastating snowstorms killing millions of livestock and endangering the survival of nomadic populations.

ASIA obtains recognition of eligibility by the Ministry of Foreign Affairs as an international cooperation NGO.



2001


A 'partnership agreement' is signed with ECHO (European Community Humanitarian Office) for emergency projects for people affected by natural disasters.


ASIA intervenes in Inner Mongolia with an emergency project funded by ECHO and OCHA following a terrible drought affecting nomadic herders.

We promote access to education, a fundamental right and inalienable opportunity for every child to access better living conditions and ensure respect for the cultural identity of peoples.


Solidarity



In particular, ASIA shares the values of peace, respect and tolerance inherent to the cultural and spiritual tradition of Tibet and considers them a heritage of all humanity.


Mission

It promotes sustainable development processes that put local communities at the centre with their human, cultural and environmental resources.



Where we operate

ASIA works to support Tibetan refugees in India and Nepal, with emergency and international cooperation projects in Bhutan, Myanmar, Mongolia and Nepal. ASIA also works with global citizenship education projects in Italy.









Governance

ASIA's sovereign body is the Members' Assembly. In 2023, there were 42 members of ASIA, including 23 women and 19 men, 36 Italians and 6 foreigners (1 Canadian and 5 Europeans).

The General Assembly has the task of identifying and outlining the general guidelines of the Association, to approve the budget, as well as the balance sheet of each financial year, which ends on 31December each year. Every three years it appoints the Board of Directors, the President (legal representative), the Board of Auditors and the Arbitrators. All the offices of the association hold office for three years, free of charge, and may be re-elected.



Organization Chart





Staff Composition







Staff Composition by Category

The well-being of the team

During 2023 at the headquarters, the ASIA team was able to benefit from two courses aimed at improving stress management, self-awareness and psychophysical wellbeing while working on team building:



A free coaching programme offered by ICF Italia, the Italian chapter of the International Coaching Federation.

We were, together with other associations, in the 'II Dono del Coaching' programme. The aim of the program, defined internally, is to 'improve confrontation, communication, and working methods by better clarifying roles and functions. It aims to simplify decision-making processes in order to create an environment that is more motivated and satisfied with one's work. The course was developed over approximately seven months through individual remote meetings. Twelve people from the ASIA Rome team did their individual course with 12 different coaches - a group course led by two coaches consisting of two meetings.

It was an important opportunity for the whole team to stop and reflect on their roles, needs and work dynamics and to share considerations and expectations.



A basic course in Yantra Yoga

Yantra Yoga, "the Yoga of Movement", is one of the oldest systems of yoga from Tibet. This involves an exclusive series of postures and movements combined with conscious breathing, through which individual energy is coordinated and harmonised.

With eight weekly meetings on Monday mornings, the team was able to start the working week in a more relaxed way, re-establishing connection and balance between body and mind.

New Management Resources

In 2023, ASIA equipped itself with a new software for managing fundraising and long distance sponsorship. After careful research and selection, NP Solutions was chosen for its experience, level of technological innovation and quality of support.

The need that prompted us to take this step is to improve the effectiveness of fundraising and to manage the organisation's activities more efficiently by renewing one of its main working tools. Thanks to the new software, we will be able to speed up and integrate various stages of the work process and optimise the time of the human resources dedicated to these activities.

OUR COMMITMENT

Our approach

In its early years, ASIA chose to focus only on Tibet and the protection of its culture, language and spirituality. From 1993 to 2021 for 28 years, we worked continuously in all Tibetan areas of China. Since 2022, due to the Chinese government's restrictions against INGOs operating in Tibet, we no longer work in China.

Over the years, we have extended our work to other countries on the Asian continent and today we are present in Nepal, Bhutan, Mongolia, India, Myanmar with development, emergency and long distance sponsorhip projects and in Italy with global citizenship education activities.

ASIA intervenes in regions inhabited by ethnic minorities to help the most needy: women, children, the elderly and the people with disabilities; choosing its interventions on the basis of criteria of fairness, justice, the fight against poverty and discrimination, without ever bowing to blackmail or the wishes and desires of political or power groups.





ASIA's approach is based on **respect for human rights** with a focus on the human dimension, the protection of fundamental freedoms, the strengthening of the rule of law, and social justice: the right to **health**, **clean water**, **food**, a **healthy environment**, **education**, **work**, **gender equality and the emancipation of women**.

ASIA is guided by the principles of **partnership**, **solidarity**, **accountability** and **transparency** and works with partners and beneficiaries on the basis of their needs and priorities, focusing on results-based projects identified with partners and fostering the exchange of information and good practices.

As far as **emergencies** are concerned, we intervene in the phase immediately following the very first emergency with the distribution of basic necessities and with reconstruction work on houses, schools, hospitals, sanitation systems and water purification.

The principle underlying ASIA's actions is that following an emergency intervention, we must work to rebuild lasting and sustainable development.

In general, we always try to ensure a **long-term presence** in specific areas, with **priority given to Himalayan areas**, which are inhabited by oppressed minorities and are of proven environmental value and relevance to climate change.

ASIA only operates within the priority areas of intervention that are designated by the General Assembly.

We promote the knowledge and experimentation of those values with a secular and universal character that Tibetan and Himalayan culture and traditions carry, because we believe that these principles can contribute significantly in providing answers to the complex global issues we face and to the growing needs of our communities.



Ethics

To ensure respect for the principles and values underlying the organisation's activities, ASIA has a set of codes and procedures to ensure fairness, objectivity and impartiality in the realisation of the Association's mission.

In particular, it has adopted:

- a Code of Ethics and Conduct, which brings together basic principles and values that determine the activities of the organisation and the conduct of all its staff, partners and enterprises supplying goods or services;
- an Anti-Fraud Policy and Anti-Corruption Code of Conduct, which formally defines ASIA's commitment not to allow any form of unlawful behaviour, corruption and fraud and to comply with the relevant laws in force;
- a Policy for the Prevention of and Fight against Sexual Harassment, Mobbing and Discrimination to protect the Integrity of People, which guarantees a work environment based on mutual respect and correct interpersonal relations, in order to improve the internal climate, the safety of workers and their performance;
- a Child Protection Policy, including a Code of Ethics and Procedure of Report, binding on all those working for and with the organisation;
- and finally, a series of Administrative and Technical Procedures (logistics, project management, human resources, safety, etc.) that define clear and impartial standards and processes, for transparent management of the organisation's activities, intact and compliant with the highest national and international industry standards.

Our commitment 2023

In 2023, we presented 26 projects to public and private donors of which 9 were approved, 6 were under evaluation and 13 were rejected; a financial residual of about 15,000 euros from a PCDM-funded project completed in 2022 in Nepal was approved for use.

The table shows that the country that received the most funding was Mongolia, followed by Nepal then Bhutan and finally Italy. In terms of amount, UBI granted the largest amount of 104 thousand euros from the 8x1000 funds for the humanitarian call. Bolzano follows with funding per country ranging between 56,000 and 41,000 euros.

A total of 23 projects were implemented in 2023 with the remaining and committed 2022 and 2023 funds in Nepal, Myanmar, Mongolia, Bhutan and Italy, of which 10 were completed during that year and 13 are ongoing and will be completed in 2024.

Nepal is the country where the largest number of projects were implemented, followed by Bhutan, confirming ASIA's Himalayan vocation.

The area of intervention most affected by ASIA projects is food security, which accounts for 34% of the projects implemented over the three-year period, followed by global citizenship education. This is followed by projects related to the preservation of cultural heritage with 16% while education falls to 10% and environmental protection to 7%. Unfortunately, despite the fact that education and the protection of cultural heritage are among ASIA's priority sectors, the number of projects has decreased due to the closure of the office in Tibet, a region where ASIA was very committed to these two sectors of intervention in order to protect Tibetan culture and education.

The amount for 2022 is much higher than the other years because no less than three PCDM projects that had been submitted in 2020 were approved during 2022 for a total amount of 583,250 euros. Without the PCDM projects in 2022, the income from projects would have amounted to 411,768 euros in 2022, which is still higher than the funds that came in during 2023.

Unfortunately, no PCDM projects submitted during 2021 entered 2023 because the projects submitted were rejected for rather questionable administrative reasons.


A worrying drop in funding during 2023 clearly emerges.

Projects in progress in 2023

Bhutan, the only country in the world with a Vajrayana Buddhist tradition, is known for its efforts to protect its ancient culture and biodiversity from exploitation and globalisation. In truth, Bhutan has also suffered a dramatic impact since opening up to the outside world in the 1960s, which has put its cultural heritage, pristine natural environment and biodiversity at serious risk. Forests, as well as works of art preserved in houses, temples and monasteries located in remote areas, have been looted and sold abroad. The government, to remedy this degradation, has over the years enacted a series of laws to protect the forests, rich in valuable timber and fauna. Above all the government has regulated tourism by establishing a tax for each day spent in the country.



In remote areas, unfortunately, income opportunities are very limited and the local people, mostly farmers or nomads, live off their own agricultural products which, more often than not, are not enough to guarantee food security for these families or economic self-sufficiency.





- The tourism industry, which is one of the Bhutanese government's main sources of hard currency, unfortunately stops in the big cities and does not reach the remote areas. To these problems, the consequences of Covid have been added. On one hand, these have limited trade with neighboring countries, not allowing young people to work abroad particularly in India. On the other hand, with the complete closure of borders, they have inhibited tourism altogether, causing a huge economic crisis and an increase in unemployed youth. This further impoverishment of the local population, and the lack of productive alternatives, has again encouraged illegal logging, poaching and art theft.
- Therefore, in order to preserve the precious culture and natural heritage of Bhutan, it is necessary to create new income opportunities for communities in remote areas and for young people without work by involving them in activities that promote the conservation and protection of cultural and historical sites and biodiversity, and by increasing agricultural production and dairy production. To do this, it is important that local communities are helped to appreciate their precious culture, beauty and richness of nature in a way that respects and preserves them for future generations, but at the same time learning how to valorise and utilise these riches in a sustainable way by creating new income opportunities for young people and their families.
- ASIA has been working in Bhutan since 2020 and has implemented 8 projects so far, reaching 4,989 direct beneficiaries in three years. Of the 8 projects, one is an emergency project to help the population prevent the spread of Covid; 2 projects to restore and develop a very old spiritual centre; 2 projects to increase the production capacities of the farmers and ensure the food security of 2 very remote districts; and finally, 2 projects to develop and improve the educational offerings of some schools located in areas far away from the main population centres.



CONTEXT

Sumthrang Monastery, founded around 1,230, is among the most important in Bhutan. Descendants of its line include Pema Lingpa. In the past it was a cultural center lively for learning, studying and practicing Vajrayana Buddhism and now it is mainly used for rituals and chanting. However, thanks to the Nyo clan, the cultural and spiritual heritage has been passed down from master to disciple and the knowledge of this entire spiritual and cultural tradition is still alive. Nevertheless, the shortage of religious figures capable of conducting rituals, religious festivals and other rituals threatens the survival of local cultural traditions, such as the Kangsöl, a worldwide cultural heritage dating back to the 13th century. Therefore, ASIA, together with the Nyo Foundation, initiated this project, with the aim of safeguarding the precious spiritual and cultural traditions enshrined in the Sumthrang Monastery.

OBJECTIVES

General Objective:

The spiritual and cultural tradition of Sumthrang has been preserved and passed on to future generations in Bhutan.

Specific Objectives:

A spiritual, cultural and vocational centre for nuns, monks and lay people with classrooms, dormitories, a kitchen, a canteen, toilets and showers for up to 50 students built in the village of Sumthrang and the successfully started secular and temporal education activity.


PROJECT ACTIVITIES

- **A1.** Establishment of a project committee with representatives from the Monastery, the Nyo Foundation and ASIA to manage the project activities.
- **A2.** Construction of a guesthouse of 117 square metres on two floors and six rooms to accommodate scholars, lecturers and visiting guests and equipped with the necessary basic services and furnishings.
- **A3.** Construction of a building with a library and classrooms totalling 172 square metres equipped with the necessary basic services and furniture.
- **A4.** Creation of a 2,500 sqm courtyard and roads, driveways and greenery for 1,250 sqm.
- **A5.** Organisation of training on logical framework, project cycle, budget control, and monitoring.

ACHIEVEMENTS IN 2023

All project activities were realised as well as all expected results. In particular:

- R1. An operating committee established and active.
- **R2.** The 335 square metre, two-storey guesthouse was built in the traditional style, painted and equipped with beds, mattresses, tables.
- **R3.** A 64 square metre library and study room was built in the traditional style and equipped with tables, bookcases and books.
- **R4.** A 241-square-metre, two-storey building with classrooms and accommodation for teachers, was completed and equipped.
- **R5.** A 2,500 square metre paved courtyard; external arrangements such as stairs, retaining walls and drainage was constructed; the access road to the monastery was cemented and made accessible to cars as well as a new area for parking vehicles.
- **R6.** On-the-job training was carried out with all Nyo Foundation staff both during ASIA on site missions and remotely.

CONTEXT

The COVID-19 emergency had strong and immediate impacts on the national economy. As a very small country, the pandemic immediately caused a food supply problem. In rural areas, many of the people who returned from India were left without work, and with the complete blockade of tourism that took place, the economic situation was extremely aggravated. Many remained in extreme poverty and malnutrition, and despite the government's efforts, the food situation worsened over time. The project aims to focus on 2 pillars: the strengthening of agricultural activities and the reinforcement of health activities in order to equip the local health system with the tools and means to stem the consequences of a resurgence of COVID or other highly transmitted diseases.

OBJECTIVES

General Objective:

To improve the living conditions of the population of Ura County after the COVID-19 pandemic.

Specific Objective:

To improve the responsiveness of the population and the local hospital to disease and improve the productive capacity of farmers in Ura County.

PROJECT ACTIVITIES

- **A1.** Selection of beneficiaries, establishment of a project committee and coordination of project activities.
- **A2.** Organisation of distributions in cooperation with the Ura County Government, the Nyo Foundation and the county departments of Agriculture and Health.
- **A4.** Purchase of agricultural implements, motor cultivators, greenhouses and equipment for fruit and vegetable stands.
- **A5.** Training of 12 groups of farmers consisting of fifteen young people each, 50% of whom are women, trained in three courses in vegetable greenhouse management; organic farming techniques; conservation and marketing of vegetable products.
- A6. Strengthening the local health system and health awareness activities.
- A7. Activity monitoring and final reports.

ACHIEVEMENTS IN 2023

R1. In order to raise awareness among the entire population of Ura County, 12 panels were produced and installed at meeting points for the local population; 308 brochures were produced and distributed in local languages and English explaining all the good practices to prevent covid and other infectious diseases.

R2. In order to improve the healthcare offer of the local hospital, a first batch of medical equipment was purchased. In particular, 10 pulse oximeters; 10 BP machines; 3 oxygen concentrators were purchased. The remaining equipment will be purchased in early 2024.





R3. In order to improve the skills of the 84 farming families, 12 greenhouses of 100 square metres each were purchased; 12 equipment kits for growing greenhouses; and seeds for growing vegetables. In recent years, the COVID-19 emergency has had a strong and immediate impact on Bhutan's economy, paralysing the production and import-export system. Many young people and migrants who have returned from India are attempting to resume agricultural activities to self-produce food for their families. While men mainly work in the construction sector, the primary activity of agricultural production is often carried out only by women. The lack of mechanisation and the difficult topography of the land, however, make it very challenging for female farmers to carry out daily tasks. It is therefore important to make farming a viable job for women as well, reducing their physical fatigue and increasing the efficiency of their techniques and practices.

OBJECTIVES

General Objective:

The project aims to increase the productive capacity of the area and the income of farming families.

Specific Objective:

Increase the presence of young female workers in the primary sector and allocate 25 acres of land to production; increase horticultural production with organic farming techniques with high agro-biodiversity; market new products in order to increase family income.

Despite the great development of education in the country since the 1960s, Bhutanese education has remained very old-fashioned and of low quality, especially in the more remote areas far from the capital. Here, the quality of teaching is lower, both because the best teachers are attracted to the cities, where they can work in better facilities and earn higher salaries, and because of the lack of IT and digital facilities. The project therefore aims to help reduce the wide gap between young people living in the cities, who are fully integrated in the modern digital world, and those living in the rural and remote areas of the country who are lagging behind.

OBJECTIVES

General Objective:

Quality of education in 2 schools increased by 50% due to increased IT skills and access to online programmes.

Specific Objective:

Digital interaction between 112 teachers, 1,277 students and parents increased by 60% through the development and implementation of a digital platform; the use of 18 multimedia whiteboards and the training received.





A country famous for its rich nomadic culture and millenary traditions, Mongolia unfortunately often remains outside the interests of international cooperation. Although life in the capital, which is home to about a third of the total population, now fairly follows western style, the rest of the population lives according to nomadic traditions in wastelands or concentrated in the gher, an area just outside Ulan Bator, in very precarious social, economic, and sanitary conditions. Added to this is serious pollution, one of the worst cases in the world, especially in the capital where, in some months of the year, the air becomes unbreathable.

- The severe cold, called dzud, which now occurs practically every year, with temperatures in the steppe reaching as low as -50°, undermines agriculture, a sector that has never really taken off also because of nomadism, and pastoralism as the animals, unable to find fodder on ground covered by metres of snow, die from lack of food and excessive cold.
- In the countryside, the education sector also has to cope with cold weather and limited resources, and families face daily challenges in providing an adequate education for their children.





- Despite these adversities, Mongolian culture remains strong and deep-rooted in the population, with celebrations of ancient traditions still very much alive, a rich culinary tradition reflecting nomadic life and the need for hearty meals to withstand the cold winter, and a huge tourism potential with breathtaking landscapes attracting the interest of visitors from all over the world.
- In this context, and despite a minor setback due to COVID-19 as Mongolia was one of the first countries to close its borders ASIA has continued to maintain its presence with international staff since 2016 and has continued to support the population with projects focused especially on the education sector (improvement of schools in remote areas, provision of water purification systems, training for teachers and students, school computerisation), and on the pastoralist sector (support for veterinarians, support in the creation of improved stables, fodder and micronutrients during dzud etc.), reaching a total of 2,646 people directly supported over the past three years.



In recent years, Myanmar has been facing a number of health, economic and political challenges that have unfortunately undermined its stability. The COVID pandemic, since 2019, has strained the country's health and economic system, with a huge impact on the tourism and export sector. The military coup staged by the Burmese armed forces on the morning of 1 February 2021 to overthrow the democratically elected government of Aung San Suu Kyi in 2015 initiated fierce clashes that continue to this day.

- Despite the complexity of the context and despite the enormous social and economic consequences that these events have caused, ASIA has continued to maintain its presence in the country, both with international and local staff, maintaining the principles of neutrality and independence, with interventions in favour of the most vulnerable population groups.
- The areas of intervention in which ASIA has been involved in the country in recent years have been emergency, food security and agriculture, managing to support 7,343 people directly over the past three years.





- ASIA has chosen to intervene in these sectors because they are crucial areas for trying to ensure the well-being and survival of people in crisis situations such as the current one.
- Emergency, an area that ASIA is also dedicated to in other countries where it intervenes, require rapid action to provide immediate assistance to people affected by health disasters or conflicts, while food security and agriculture are key to ensuring that communities can have access to nutritious and sustainable food in the long term.
- In addition, intervention in these areas promotes the resilience of communities, providing them with the skills and resources they need to cope with any future shocks or crises.
- In this way, ASIA wants to contribute to improving the living conditions of the most vulnerable people in the country and to promoting sustainable and inclusive development.

Nepal is a country of immense cultural, linguistic and natural wealth, located in the central Himalayan region close to the borders of India and the Tibetan Plateau. Despite its great cultural heritage and diversity, the country is among the poorest in the world, and in the last 3 decades has suffered the blows of a civil war, 2 devastating earthquakes and the covid-19 pandemic, further slowing its development and causing high emigration rates. Rural Nepal is characterised by subsistence farming patterns based on the family unit, and by topographical and production difficulties that are exacerbated by climate change and monsoon variability, contributing to the undermining of the population's food security and exacerbating the phenomenon of abandonment of these areas and the emigration of young people from the country, with serious social, cultural, economic and environmental consequences.

ASIA has been working in Nepal since 1996, with the objective of promoting sustainable development processes in the rural areas of the country, supporting the preservation of the Himalayan cultural and spiritual heritage. Over the past 27 years, ASIA has intervened in Nepal improving the living conditions of the population with agriculture, agroforestry, health and water, education and emergency projects implemented in 14 districts of the country.





In these districts, ASIA has promoted rural development and climate resilience projects for production systems, promoting climate-smart farming practices, agroforestry activities aimed at reducing the unregulated extraction of natural resources and the protection of local biodiversity, reforestation, and the development of value chains for highly profitable products (honey, spices, organic seeds), with the aim of improving the socio-economic conditions of rural producers, reducing the abandonment of these areas and conflicts related to the use of natural resources. ASIA has also implemented WASH projects aimed at improving the sanitary conditions and access to water for the beneficiary populations, education and long distance sponsorship projects aimed at improving the conditions and quality of education for Himalayan students, and projects to protect the Himalayan and Tibetan cultural and spiritual heritage.

ASIA has also been active in all the major emergencies that have hit the country, from the 2015 earthquake, where the organisation supported more than 10,000 families with temporary housing and schools, reconstruction of damaged water systems and the rebuilding of schools, to the covid-19 pandemic, where it supported hospitals in several districts of the country with oxygen concentrators, vulnerable families with food supplies and awareness campaigns to the most recent earthquake in November 2023, which hit the Karnali region, where ASIA has intervened immediately with the construction of shelters for homeless families and temporary schools.

Over the past 3 years, ASIA has reached 35,420 people directly with projects.

The project is carried out in cooperation with the Triten Norbutse Institution, the one and only institution legally registered in Nepal for the purpose of keeping the methods of traditional Tibetan Bönpo medicine alive. The training programme taught is the entire Bon Bumshi medical system and is open to anyone interested in becoming an Amchi doctor. The aim of this intervention is to support the Himalayan population with little access to health facilities by keeping very effective traditional methods and medicines alive for treating and preventing various types of illnesses.

CONTEXT

Ancient Tibetan medicine is rooted in the Bön culture, which predates the arrival of Buddhism in Tibet and Nepal by several centuries, and is still practised in Nepal, particularly in the remote areas of the Himalayas, where it is the only real alternative to the absence of hospitals and medical infrastructure providing modern medical services. It is also a type of medicine that is accessible even to the poorest sections of the population in Nepal.

After diagnosis, the Tibetan doctor (Amchi) recommends the abandonment of harmful behavior and recommends a diet suitable for the patient. If prescribed, remedies are mainly composed of medicinal plants with healing and mineral properties, while body therapies include acupuncture, kunye massage and moxibustion.

The school aims to offer young Himalayans a professional perspective and, in the medium term, will contribute to improving health services for the population in the remote mountainous regions of Nepal, where the absence of basic health services is a real obstacle for the local populations.

OBJECTIVES

Generale Objective:

Improving primary health care in remote areas of Nepal through the establishment of a traditional medicine school and the training of qualified traditional Himalayan doctors.

Specific Objectives:

Create learning opportunities by building facilities for traditional medical education and capacity building for students and traditional doctors in the Himalayan region. Enabling the poorest segment of the population in rural Nepal to have access to adequate care.

Preserving traditional Tibetan culture and promoting intercultural exchange between western and traditional medicine.





PROJECT ACTIVITIES

A.3 - Construction of the building.

In 2023, at the end of July, the construction of the building was completed and it was finally handed over to the beneficiaries (students and teachers). The building houses the canteen, kitchens and teachers' quarters. While waiting for the building that will house the classrooms and library yet to be constructed, some rooms are being used for regular classes. In addition, an area has been set aside on the terrace for the drying and storage of medicinal plants needed for the preparation of medicines.

Furthermore, environmental deterioration is becoming a new problem in Nepal and the project areas. Therefore, agroforestry is one of the best ways to cope with this situation and local knowledge in agroforestry, education and development practices are essential to improve this practice.

OBJECTIVES

General Objective:

Reducing poverty in Nepal through increased competitiveness of international trade and the domestic coffee market, and improving marginal land use in the Rasuwa, Nuwakot, Tanahu and Lamjung districts through fruits, fodder and multipurpose trees.

Expand the area of coffee orchards and increase coffee production in the country. Supporting the use of marginal land and the export of products.

Improve forest areas in Rasuwa, Nuwakot, Tanahu and Lamjung districts by planting productive species.

Initially, the monastery complex consisted of only a small temple, but over the years the area has expanded to include a residential building for the monks and a temporary open-air school facility, covered with sheet metal and exposed to the elements. The boarding school currently houses 60 young students, aged between 10 and 16, who live in six rooms in very precarious conditions due to the lack of space and inadequate facilities. For years, the monastery has been providing accommodation, food and a bilingual education to the young people housed there, with the aim of countering the loss of the cultural and linguistic heritage of the Himalayan minorities and providing equal opportunities to the monks who decide to live a secular life once they have grown up and finished their studies.

OBJECTIVES

General Objective:

Ensure the linguistic and cultural preservation of the linguistic minorities in the Himalayan area.

Specific Objectives:

Ensuring equal learning opportunities for young people from the linguistic minorities in the Himalayan region.

Improving the quality of formal, bilingual education provided in the monastery at Pal Tashi Choeling school.

Improving the living conditions of the students at Pal Tashi Choeling school.

- **A1.** Establishment of a project supervision commission.



In 2023, a water system management committee was established, the water source was identified and registered, and approval was received from local government authorities to construct the water system. Water potability tests revealed a high degree of water contamination (related to the use of the source by wild and grazing animals), which required a re-evaluation and reformulation of the water system construction drawings and materials prepared during the project preparation phase. It was decided to completely isolate the spring, in order to avoid any risk of water contamination, and to create a tank to allow animals to drink water. The project will be completed by April 2024.



CONTEXT

On 3 November 2023, at 23:47, a 5.7 magnitude earthquake destroyed 17,792 houses and severely damaged 17,529, causing 156 deaths and 349 injuries in the districts of Jajarkot and Rukum West. ASIA immediately went into the field to collect the necessary data to formulate an emergency response, identifying as target areas the villages of Shirpachaur and Bayalatole, located in the Rural Municipality of Barekot, the closest to the epicentre of the earthquake.



OBJECTIVES

General Objective:

Supporting the earthquake-stricken population of Jajarkot and Rukum West districts in coping with the emergency through the provision of shelters and semi-temporary schools.

Specific Objective:

Supporting the earthquake-stricken population of the villages of Shirpachaur and Bayalatole in Jajarkot district in coping with the emergency through the provision of shelters and semi-temporary schools.

PROJECT ACTIVITIES

During November and December 2023, the target villages were identified and preliminary designs for temporary schools and shelters were produced, and the tender for the procurement of materials for the construction of the temporary shelters (CGI panels) was opened. The distribution and construction of the shelters and the construction of two semi-temporary schools are planned for early 2024.





ACHIEVEMENTS IN 2023

In 2023, the target villages of the intervention were identified, the tender for the supply of materials for the construction of temporary shelters was opened, and the supplier company was selected.

For about 20 years, ASIA has been involved in Italy with projects to raise awareness of various aspects of Tibetan culture and international cooperation issues, by organising exhibitions, conferences, university seminars, publications and courses in schools.

- Since 2019, the focus of the projects has expanded to include, in addition to the intercultural aspect, the socio-emotional aspect, in order to respond to the growing need for self-awareness, empathy, emotional regulation and conflict management manifested in particular by children and young people.
- In recent years, in fact, the emotional distress of young people has been worryingly increasing: in a recent report, ISTAT certified that in 2021, 6.2 per cent (the year before it was 3.2 per cent) of 14-19 year olds, more than 220,000 young people, were dissatisfied with their lives and experienced poor mental health.





According to the WHO, suicide is today considered to be one of the three main causes of death among individuals between the ages of 15 and 44, and is estimated to be the leading cause in the future. Among the multiple causes of this strong malaise is often a problem of emotional illiteracy, as well as extreme individualism, which leads young people - and not only them - to feel isolated and separated from others and their environment.

This is why we have started to support schools, both primary and secondary, in the dissemination of the so-called soft skills, those relational competences made up of emotional education, awareness of one's inner world, and empathic communication skills, which are at the basis of a person's psycho-physical wellbeing and health, drawing inspiration from the values and principles of Buddhist culture and reaching 11,209 direct beneficiaries over the last three years among students, teachers, family members, and civil society.

The year 2023 started with the last activity of the project "Educating to defend animal rights and protect the environment for a sustainable future of planet Earth", the webinar "Animal Landscapes. The human-animal relationship between history, environment, psychology and religion", which was attended by well-known speakers and experts in their respective disciplines and a very interested audience.



- During the year, the project 'Let's Make Peace. Taking care of one's inner enemies to make peace with the outside world' with which we worked on awareness and making peace with one's inner world as a necessary condition to establish relationships based on respect, listening and empathy and a new project 'We are One. From the illusion of a separate self to the awareness of an interconnected self' began. This aims to alleviate the sense of separation and isolation widespread among young people, giving them useful tools to develop a more empathic and connected self with others and the environment.
- Finally, in 2023 we continued the activities of 'Green school Italia: network of schools and territories for sustainable development' through which an increasing number of schools are acquiring the tools to apply good practices in the direction of environmental sustainability and the fight against climate change.



LONG DISTANCE SPONSORSHIP

Long Distance Sponsorship (LDS) is a fundraising method that allows us to support schools of all levels (from kindergarten to high school), monasteries, monastic colleges and homes for the elderly every year, improving the living conditions of those in need in the cultural and social environment to which they belong. Long distance sponsors undertake to send a stable and continuous economic contribution to these children, young people, the elderly, monks and nuns, guaranteeing them dignified living conditions and the possibility of receiving an education that respects their cultural identity, with the aim of maintaining and passing it on.

Thanks to the Long Distance Sponsorship we participate every year in the 2030 Agenda for Sustainable Development and contribute in particular to the realisation of these Development Goals:










The number of long distance sponsorship projects active each year is constantly changing and this depends on various factors, the main ones being: number of new starts, number of closures, number of renewals, project openings/closings and the timing of reporting on these factors.

The aim of the Annual Report is to give an account of the year on all ASIA's activities and for this reason the period from the beginning of January to the end of December is taken as the period of analysis, but it is important to emphasise that this purely temporal choice does not suit the LDS project since the number of the sponsorships varies and changes from day to day and the 'snapshot' on 31 December may not reflect the current situation.

This year, following a 2022 settlement following the closure of the projects in Tibet, closed with **a total of 1,258 active LDS and 822 supporters**, registering a decrease in the number of active LDS (2022 ended with 1,325 active LDS and 903 supporters) but continuing with the positive trend of starting new projects: 2 primary schools.

In conclusion, considering the activities carried out, the resources deployed and above all the global economic, geopolitical and social situation, this is a result that is not entirely satisfactory but in line with external circumstances.




LDS 2023 IN NUMBERS


New LDS and closures

2023 saw a slight decrease in the number of requests to start new supports (63, compared to 74 in 2022), a factor probably influenced by global economic and geopolitical trends (inflation and wars). On the other hand, there was also a slight decrease in the discontinuation of supports compared to the previous year, with 185 LDS closed compared to 192 in 2022.

New LDS 2022 - 2023




LDS closures 2022 - 2023




With respect to the type of beneficiaries, 2023 saw a general decrease in all new support, but a consolidation of the requests for new support in favour of children (33), compared to the previous year (32). Compared to 2022, start-ups in favour of the elderly increased and requests for new LDS in favour of children and secondary school students (scholarships) decreased.

Of the 185 closures, 54 are supporter-related while 131 are due to changed circumstances of the beneficiaries. Below are the specific reasons:

The number of supporter-related closures increased


(+12 compared to 2022), reflecting on the one hand the insolvency of some supporters (+11 compared to 2022) and on the other hand the latest aftermath of the project closures in Tibet. Furthermore, it is of importance to note that compared to 2022, closures due to economic difficulties decreased (-4).

The number of closures due to changed conditions of beneficiaries decreased this year

compared to the previous year (131 compared to 150 in 2022). This is due to the monitoring of the movement of beneficiaries, as the number of transfers of our beneficiaries between the institutions we support is increasing year by year (+10 compared to 2022). The closures were communicated to the respective supporters, most of whom immediately decided to renew their commitment (see details in the following section). As of 31 December, 76 LDSs remained closed, of which 30 because supporters were unable to renew their commitment and 46 of supporters who have not yet responded to the closure notices (these figures correspond to the number of beneficiaries and not to the actual number of supporters, which may correspond to several supporters).


LDS renewed

During 2022, a total of 63 LDSs were renewed, i.e. new distance support initiated following the departure of beneficiaries and the closure of previous support. Of the 63 renewed supports (including 8 new supports from closures relating to 2022), 42 are in favour of children, 9 in favour of monks, 9 in favour of the elderly and 3 in favour of high school students (scholarships). This figure is strongly influenced by the type of beneficiary who has left the programme: in most cases, supporters choose to renew their long distance sponsorship in favour of another beneficiary in the same category.



LDS trend 2023

development of the Long Distance Sponsorship project during 2023 replicated the typical trend of previous years. As in the previous year, the number of active LDSs fluctuated (see figure below) with moments of sharp decreases, linked to the end of the school year and the consequent leaving due to the end of studies, followed by a steady fluctuation. Compared to previous years, the usual increase due to the Christmas period missing, possibly caused was by the Christmas campaign focused the on earthquake emergency in Nepal.



Long Distance Sponsors

2023 welcomed 39 new supporters (of which 10 are former supporters) for a total of 847 distance supporters. During the year, 7 supporters with active support decided to increase their commitment, supporting 7 more beneficiaries, which always makes us very proud considering the global economic, geopolitical and social situation and the management challenges of increasing the number of new projects.

Of the 847 long distance sponsors, 25 chose not to have personal support, donating to a German fund dedicated to them, which covers 26 LDS this year. Of the remaining 822 sponsors, the majority (690 people) support a single beneficiary, but it is noteworthy that as many as 82 people support at least two beneficiaries, and there are 8 sponsors who have more than 10.

ASIA's sponsors come from many parts of the world; among the most represented countries we have Italy in first place (with 678 sponsors, 62 fewer than in 2022), followed by Germany (60), France (40), the USA (16), and Spain (13).

in France

The situation has changed little since last year. The number of active LDS increased by 1 and the number of supporters by 2. There are 36 sponsors and the number of active LDS is 49 (35 children, 11 monks, 2 high school students and 1 senior).

in Germany

The number of benefactors has decreased while the number of active LDSs has increased slightly. Specifically, in 2023 there were 50 sponsors (25 of whom donated to the non-personal fund) and 77 active LDS. Specifically, German supporters supported 44 high school students (scholarships), 6 monks, 1 senior citizen and 26 children.

LDS in Bhutan

2023 saw the start of a new project in Bhutan for the Tshangkha Central School, Trongsa. Support continues to be given to Sumthrang Monastery, which currently houses only 3 nuns following the passing away of the abbot. Although the monastery has now lost its original group of 10 nuns, it is working to obtain recognition from the Ministry of Education as a monastic school for Buddhist studies, registered both locally and worldwide. The institute is developing its curriculum and school policies and aims to start recruiting new male and female students soon.



LDS in India

In India, there were 19 active LDS projects in 2023 (7 if TCV, CST and STS schools were considered as unified under the 3 acronyms). The number of long distance sponsorships in December 2023 was 609, 33 less than in 2022. All schools under the administration of the Department of Education of the Tibetan Government in exile, the Central Schools for Tibetans (CST) started during 2022 to come under the direct management of the Sambhota Tibetan School Society (STSS) and it was expected that in 2024 the CST Darjeeling and Kalimpong projects would also be closed and all long distance sponsorships shifted permanently to STSS.

DESCRIPTION

In India, the long distance sponsorship project is implemented at many of the Tibetan schools founded following the Dalai Lama's exile and attended by children and young people from the main Tibetan settlements. Long distance sponsorship helps to cover the expenses incurred for the upkeep, education (from kindergarten to university) and training of these students, who live in school accommodation or at home, and who are also provided with medical care and as familiar a living and studying environment as possible. In addition to the support for students, there is also the unique long-distance support project in India for the elderly, who live in the homes of the Tibetan Homes Foundation, or in settlements throughout India. Thanks to the project, help is given to cover the costs incurred for the maintenance and care of elderly Tibetans who are left alone or are ill, and therefore can no longer support themselves. Since 2022 there has also been a LDS project in India for Tibetan nuns, many of them elderly and without families, who live at the hermitage of the Sacred Cave of Guru Padmasambhava.

SAD in Nepal

In Nepal, 15 LDS projects were active in 2023, one more than in 2022. In fact, a new project was started: in favour of the Namgyal primary school (the same institute where the Scholarship project in the secondary school was already active). The year 2023 saw a significant decrease in the number of active sponsorships in this country to 633, 47 fewer than in 2022.

In Nepal, the long distance sponsorship project is implemented at 11 schools (6 Tibetan and 5 Himalayan, 2 of which are high schools) and 4 monasteries. At the schools, the support helps to cover school fees for the poorest students, from kindergarten to high school, and enables the institutions to ensure a quality education and study environment for all. 
In India, Nepal and Bhutan, a high degree of education is the only opportunity for young people to build a future and contribute actively to the society in which they live. However, the best training schools, colleges and universities are to be found in the big cities where, in addition to tuition fees and the cost of teaching materials, high living costs are added. Many families, usually shepherds, farmers or seasonal workers, cannot afford to help their children, and although the students themselves sometimes work part-time jobs for their livelihood, the small income generated by these jobs is never enough.

Moreover, public scholarships are difficult to obtain and those students who manage to get into the most prestigious universities, but cannot afford the fees, have to drop out and in some cases interrupt their studies, with serious consequences for themselves, their families and the entire community.

ENRICO DELL'ANGELO FUND

The Enrico Dell'Angelo Fund, set up in 2018 to honour the memory and legacy of Enrico Dell'Angelo, is a project created with the main objective of supporting university or vocational studies of young Himalayans with proven skills and strong motivation, in order to improve the overall quality of life in the areas where they live and to spread their culture and traditions around the world. The total amount of each scholarship granted by the Fund depends on the total cost that each beneficiary must bear until the end of the study cycle and corresponds to 75% of this total cost (the remaining 25% must be covered by the student themself as proof of their commitment).

Since the Fund's inception to date, 13 scholarships have been granted to 5 male and 5 female students, for university and vocational courses of varying duration (from 1 to 5 years).





FUNDRAISING AND COMMUNICATION

In the first part of 2023, the activities of this sector gave continuity to the Christmas 2022 campaign, 'Hidden Treasures', raising awareness of the importance of preserving and supporting the heritage of culture and spirituality preserved in monasteries of Buddhist tradition in Tibetan refugee communities in India and Nepal. The 5x1000 campaign also highlighted the same need, focusing on the urgency of supporting the vulnerable in the Tibetan diaspora.

The second part of the year was characterised by a series of changes in the direction of a renewal of the sector:

- there was a turnover in Communication, with a new manager joining the team in November;
- we invested in a new management software Give by NP Solutions which allows us to modernise the activities of the sector and integrate its different components;
- in November an earthquake struck Nepal again and consequently Fundraising and Communication activities focused on supporting the communities left homeless and without shelter in the freezing Himalayan winter;
- ·in November the first solidarity trip to Nepal started, initiating a new ASIA activity.



Initiatives and Events

The year 2023 was characterised by greater synergy and collaboration with other associations, with whom we organised awareness-raising and fundraising initiatives throughout Italy, as well as promoting our usual annual events.

The first events of the year were those organised by ASIA Trento: three initiatives - in January, April and May - to tell civil society about the environmental protection project project carried out with funds from the Autonomous Province of Trento and completed at the end of 2022. It was to follow up on one of the activities begun with the project, that of training beekeepers, which was carried out in collaboration with the Associazione Apicoltori Trentini. With the first two awareness-raising and information events, "Assaporando il Nepal" ('Tasting Nepal') we brought the public closer to Nepal's culture through its culinary traditions. With a video and the testimonies of the Associazione Apicoltori Trentini, we recounted the situation of the women of Rasuwa. With the third event, a concert by Serefe (a group of musicians who are alumni of the Conservatories of Verona and Trento) we raised funds to support these women by continuing their training and equipping them with the necessary equipment.



In April, we organised the webinar "Educazione Etica e Benessere" ('Ethical Education and Well-Being') together with the association EduEES, which is disseminating SEE Learning - Social, Emotional, and Ethical Learning - in Italian, with the aim of publicising the respective 'heart and mind' education work we are carrying out in Italian schools.


In May, we were invited by the bistro association Come un Albero, which focuses on the inclusion of disabled people - to talk about Tibet and our work. Two operators, with the support of pictures and videos, introduced the audience to the culture and recent history of Tibet, as well as to our projects.

In May, we were also present at the Yeshi Namkhai retreat in Merigar with a fundraising stand run by our workers and some volunteers.

In July, we concluded the project 'LET'S MAKE PEACE. Taking care of inner enemies to make peace with the outside world', cofunded by the Italian Buddhist Union, with the interreligious conference "Il Disarmo Interiore. Vie contemplative in dialogo sulla Pace" ('Inner Disarmament. Contemplative Ways in Dialogue on Peace'), hosted by A.Me.Co. in Rome. The conference - also organised online - was an opportunity to exchange and share contemplative ways and paths of 'inner disarmament'. Speeches by philosophers and exponents of some of the main religions (Buddhism, Bön, Christianity, Islam, Judaism, Hinduism) stimulated the participants' reflections, enabling them to come into contact with different methods of peacemaking with oneself.



ASIA was included among the beneficiary associations of the **Concerto per un Fiore** ('Concert for a Flower'), organised in mid-July in Osoppo (UD) by the cultural association Friuli Adventures. During the event a group of volunteers ran an information and fundraising stand with our T-shirts and other solidarity gifts.



After the summer break, in September, we were invited to the Epicentro Festival, dedicated to International Solidarity and organised by the Spiragli association in Altamura, where we were able to introduce the issues we work on and our projects to the local community.



November saw the start of ASIA's first solidarity trip. A group of 11 supporters and donors, led by one of our staff members, travelled to Nepal for a fortnight, visiting some of our projects and major cultural and scenic sites. The feedback was very positive: some supporters had the chance to personally meet the beneficiaries of their distance support (a little girl, a young student and a monk), and all of them really appreciated getting to know our projects directly and getting in touch with the local communities, their traditions and lifestyles



After returning from the trip, some supporters organised events where they talked about the trip and raised funds for our intervention to support Nepalese communities affected by the earthquake:

- A **SOLIDALE APERICENA** in Modena was enriched with images and travel stories
- An evening of fundraising, stories and travel pictures was organised in Como at the auditorium in San Fermo della Battaglia.





• At the customary **APERITIBET** organised in Rome together with Zhenphenling, the momo aperitif and the presentation of the Christmas campaign were enriched by the account of a supporter's trip to Nepal.

Finally, this year we again organised the **APERITIBET** in Naples together with Namdeling, and we took part in the 10-year celebration event of Dzamling Gar together with the International Dzogchen Community by conducting a **Tibetan Calligraphy Course for participants.**



Campaigns

In early 2023, we continued to emphasise the importance of preserving the heritage of culture and spirituality and supporting the Tibetan refugee communities in India and Nepal, the unique and precious custodians of this heritage. With the 'Hidden Treasures' campaign and the '5x1000' campaign, we have conveyed this message and focused on supporting the nuns and monks and the vulnerable in the Tibetan diaspora.

In the middle of the year, we received a request for help from the Tibetan community of Boudhanath to support the medical expenses of a severely burnt person and launched a fundraising campaign.

At the end of the year, we dedicated our Christmas campaign to supporting the Nepalese communities affected by the earthquake on 3 November, with a special focus on the needs of children.

Here are the campaigns promoted during the year in detail:

HIDDEN TREASURES

the campaign launched at Christmas last year to support the nuns of the Padmasambhava hermitage (Tso Pema, India) and the other silent custodians of Tibet's spiritual heritage. In the first months of the year, the campaign was promoted with DEM and social media posts, focusing both on long-distance adoption of the nuns and monks and on donations to support the monasteries.





DAI IL TUO 5X1000 AL TIBET, NON FARLI SCOMPARIRE (GIVE YOUR 5X1000 TO TIBET, DON'T LET THEM DISAPPEAR)

We have kept the claim of the 2022 campaign, while modifying the graphic concept, for which we have used images of Tibetan nomads to signify the authentic Tibetan tradition and way of life. We have focused on the fact that the ancient knowledge and values of the Himalayan traditions are very relevant and useful to respond to the challenges of our globalised world, emphasising the value aspect: these populations embody non-violence, compassion, interdependence and are the guardians of a fragile yet precious ecosystem for the whole of humanity, in which they have lived in perfect harmony for millennia.

The campaign was promoted with DEM and a paper letter to our internal target group, and was also supplemented by sending an SMS.

It was also disseminated on social media and bookmarked at events in attendance.


SURGERY TO LIVE

In July, we received a request for help from Tsultrim Sangmo, headmaster of the Manasarovar School, for Dolma Tamang, a Tibetan refugee from Boudhanath and mother of two former students at the school. Dolma was the victim of a terrible domestic accident: due to a gas leak in her kitchen, she suffered second degree burns on 26% of her body.

The surgery, hospital stay and medical treatment were very long and costly, and as health care in Nepal is paid for, the solidarity of our supporters made all the difference for Dolma.

We activated the 'Surgery for Living fund' and with a DEM we appealed to long-distance supporters and constantly updated them on Dolma's health condition, who fortunately has recovered and resumed her daily life.





SOS HIMALAYAN CHILDREN. LET'S SECURE THEIR FUTURE.

Following the earthquake on 3 November, our team in Nepal immediately mobilised to organise humanitarian aid. The most distressed remote villages were identified and the fundraising campaign immediately started.

With a paper mailing - separate for 2 target groups, donors and distance supporters on the one hand and former sponsors and contacts who never donated on the other - some DEM and communication on social media, we asked for help in distributing and setting up shelters and temporary schools in Jajarkot and Rukum West districts.





Solidarity Gifts

Solidarity gifts in 2023 were enriched with two new products:

T-SHIRT MESSAGES FROM TIBET

-The Messages from Tibet line - rings and bracelets in silver and steel - were joined by the new Tshirts, made with organic cotton and non-toxic inks by O' PRESS, a social project that uses materials from Fair Trade certified suppliers and prints inside the Marassi Prison in Genoa.

ENDLESS KNOT

The infinite ceramic knots made by the boys of 'Nciarmato a Nisida, the ceramics workshop of the Nesis social cooperative, inside the Nisida Juvenile Penitentiary Institute (Naples).

As always, the time of year when we most promoted solidarity gifts and raised the most funds was the pre-Christmas period.

The 2024 Calendar was dedicated to Tibetan refugee children in India, with beautiful black and white photographs taken by Alessia Bulgari in the Tibetan Children's Village in Dharmasala.





Communication

In 2023, in addition to promoting the fundraising campaigns, communication reported on ASIA's work in the field through **ASIA News, the quarterly newsletter** sent out at the beginning of each season, and the usual posts and stories on social media. This year too, visibility has been given to the events, organised both to promote the fundraising campaigns and distance adoptions, and as part of the Global Citizenship Education projects, which were given visibility on all our channels.

As every year, we were featured with an update article on our work in the quarterly magazine of the International Dzogchen Community, the Mirror.

In 2023, we continued to promote cultural columns. Various themes were explored: **Losar**, the Tibetan New Year; **Notes from Tibet** - the melody and spirituality of ritual musical instruments; **Holi**, the Indian festival of colours celebrated in the days preceding the full moon of the month of phalguna (February-March).

This is some data on communication on Facebook and Instagram:

INSTAGRAM PERFORMANCE

During 2023, extensive space was given to the Instagram channel, with an increase in the publication of content on this social network. The coverage figures increased markedly compared to the previous year.



FACEBOOK PERFORMANCE

In 2023, ASIA's Facebook profile continued to be manned with institutional editorial programming, and despite less post coverage we achieved more interactions with organic coverage, indicative of a strategy more capable of creating a relationship with our target audience.



FOLLOWERS

Net followers increased by 21%, and fewer people chose not to follow the page. These results were achieved through more targeted planning and a more appealing editorial plan.



VISITS

Visits to Facebook and Instagram profiles have also increased significantly, thanks to more impactful actions, such as sharing content from profiles belonging to partners and donors, in a networking and collaborative approach that meets the needs of the industry and the medium.

General part

1. General information on the institution

ASIA, Association for International Solidarity in ASIA, is a Non-Governmental Organisation founded in December 1988 by the will and commitment of a group of scholars of Tibetan culture.

President and founder of the organisation was Chögyal Namkhai Norbu, from whom ASIA continues to draw inspiration in promoting initiatives to safeguard Tibetan culture.

ASIA implements emergency and development projects in Asian countries and in particular in the Himalayan belt in the fields of education, protection of cultural and spiritual heritage, environmental protection and combating climate change, food security and sustainable agriculture and public health.

It promotes the right to education through distance support and works in Italy with Global Citizenship Education projects.

The main objective of ASIA's work is to promote the economic, social and health development of Asian ethnic minorities whose cultural identity is threatened. ASIA is accredited with the following decrees at:

- Entry in the Single National Third Sector Register under no. 7299;
- Italian Agency for Cooperation and Development, by Decree No. 2016/337/000136/0;
- Prefectural Register of Legal Persons of Grosseto, Decree No. 190;
- Regional Register of Lombardy Associations, section International Relations, no. 89.

In addition, ASIA is recognised as eligible for EU agency funds for cooperation and development.

In all these years in India, Nepal, Mongolia, Myanmar and Bhutan ASIA has helped more than 1,500,000 people. In addition to having acquired professionalism and experience in the management of development and emergency projects, ASIA and all its staff in Italy and around the world have absorbed and made their own the values encountered in many of these ancient cultures. Values such as awareness, compassion, altruism, openness to different cultures and direct involvement of local communities have become an integral part of ASIA's work. The aim of our Association is not only to fight poverty but to create a culture of peace and tolerance in order to participate in the creation of a better society, respectful of the individual and the environment in which he or she lives.

The association carries out the following activities of general interest under Article 5 of the Third Sector Code:

- a) Development cooperation, pursuant to Law No. 125 of 11 August 2014, as amended;
- b) Long Distance Sponsorship;
- c) Promotion of the culture of legality, peace among peoples, non-violence and unarmed defence;
- d) Promotion and protection of human, civil, social and political rights.

The bodies under the current Statute are:

- Members' Assembly;
- Board of Directors;
- President and legal representative;
- Board of Auditors, currently Monocratic Auditing Body;
- Board of Arbitrators

The Assembly

The Assembly is the sovereign body of the Association. The Assembly meets at least once a year in ordinary session upon convocation by the President by written notice. Within the remit of the Ordinary Members' Meeting are, inter alia:

- The election and dismissal of members of the Board of Directors;
- The election and dismissal of the President;
- The election and dismissal of the Vice-President if necessary chosen from among the members of the Board of Directors. The deputy President replaces the President in all his duties whenever the latter is prevented from exercising his functions:
- The appointment and dismissal of the Board of Auditors;
- The appointment and dismissal of the Board of Arbitrators;
- The appointment of the statutory auditors;
- The approval by 30 June of the balance sheet for each financial year ending 31 December; the budget and the annual report;
- Outlines the strategy and general directions of activities and priority areas;
- Deliberates on the possible allocation of profits or operating surplus however denominated, as well as of funds, reserves or capital during the life of the Association itself, if this is permitted by law and by these Articles of Association;
- Ratification of the appointment, forfeiture of withdrawal and resolution on the exclusion of members;
- The promotion of liability actions against members of corporate bodies;
- Passing resolutions on other matters assigned by law, the memorandum of association or the articles of association to its competence.

The Board of Directors

The Board of Directors is the executive body of the Association and is currently composed of nine board members, including the President and Vice President, all elected by the Members' Assembly. Board members hold office for three years and until the date of approval of the budget.

The President is elected by the Assembly from among the members of the Board of Directors for their talents and merits acquired in the field of the preservation of Asian cultures and in particular Tibetan culture. Each President may express a non-binding opinion on the appointment of a successor. The President holds office for three years, until the date of approval of the budget for the last year of his office and the election of new councillors, and may be re-elected.

The President of the Association is the legal representative of the Association before third parties and acts and resists before any administrative or judicial authority by appointing lawyers

The Control Body

The Control Body monitors compliance with the law and the statutes, compliance with the principles of proper administration, the adequacy of the organisational, administrative and accounting structure of the Association and its actual organisation. The members of the Control Body are entitled to attend, without voting rights, the meetings of the Board of Directors and those of the Assembly approving the budget.

The Board of Arbitrators

The Board of Arbitrators consists of three members, who have been members of the Association for at least five years, elected by the Assembly outside the Board of Directors. The Board is elected for the same term of office as the Board of Directors. Any social dispute between the members and the Association or its bodies shall be submitted, to the exclusion of any other jurisdiction, to the competence of the Board of Arbitrators. The Arbitrators shall judge ex bono et aequo without any procedural formalities and their ruling shall be final.

2. Data on members, founders and their activities

In 2023, there were 42 members of ASIA, of whom 23 were women and 19 men, 36 Italians and 6 foreigners (1 Canadian and 5 Europeans) in addition to the founding members. ASIA's members participate, on a democratic principle, in the assemblies convened to approve the budget, amend the articles of association and other assembly activities. They participate in the association as stipulated in Articles 11 and 12 of the current statutes. ASIA adopts the ordinary taxation regime and since it does not have any commercial activities, it is not subject to IRES.

Illustration of balance sheet items

3. Criteria applied in the valuation of balance sheet items

The financial statements, in compliance with the provisions of Ministerial Decree of 5 March 2020, are drawn up in accordance with the general clauses, general financial statement principles and valuation criteria set forth in Articles 2423, 2423-bis and 2426 of the Italian Civil Code and the national accounting standards OIC, insofar as they are compatible with the non-profit nature and the civic and solidarity and socially useful purposes of Third Sector entities.

In particular, the rules, of recognition and valuation, contained in the national accounting standards OIC have been observed, with the exception of the specific provisions set out in the national accounting standard OIC 35 for entities that draw up their financial statements according to the provisions of Article 13 of Legislative Decree 117/2017 (Third Sector Code).

The institution used fair value as the valuation criterion for non-synallagmatic transactions received during the financial year 2023 (Fair Value).

The accounting items shown in the statement and in this report are given the meanings, unless otherwise specified, set out in Annex I to the Ministerial Decree of 5 March 2020.

The items were valued on a prudent basis, with a view to the continuation of the business, in accordance with the accrual principle.

It should be noted that no items have been merged or eliminated with respect to the ministerial model and that there are no items that could fall under more than one heading in the balance sheet format for which it is necessary to provide information for the purposes of understanding the financial statements.

In the preparation of the financial statements, the accrual principle has been adopted and, therefore, the effect of transactions and other events has been recognised in the accounts and attributed to the financial year to which these transactions and events refer, and not to the year in which the relevant cash movements (receipts and payments) materialise. This report has been prepared on the assumption of associational continuity. The financial statements and this Mission Report are expressed in euro units. In particular, the valuation criteria adopted in drawing up the financial statements were as follows:

Tangible fixed assets

This item includes all those tangible assets at the disposal of the Association, with a duration of several years. Tangible assets are recorded at purchase cost, including any directly attributable accessory charges and VAT, since this is not deductible pursuant to Article 72 of Presidential Decree 633/72.

Fixed assets whose value at the balance sheet date is permanently lower than their book value are recorded at this lower value and the difference is charged to the income statement as a write-down.

Depreciation allowances, charged to the statement of operations, were calculated on the basis of the use, destination and economic-technical life of the assets, based on the criterion of residual possibility of utilisation.

The rates applied are as follows:

• works of art: 0%

• fittings and furnishings: 12%.

electronic equipment: 20%.

Financial fixed assets

They are recorded at cost, adjusted for impairment losses. Financial fixed assets consisting of loans are valued at acquisition cost. Other securities are stated at acquisition cost including directly attributable accessory charges and excluding interest accrued at the date of transfer.

Receivables

Accounts receivable represent rights to collect, at an identified or identifiable maturity, fixed or determinable amounts of cash, or goods/services of equivalent value, from customers or other parties. Receivables are stated in the balance sheet at their estimated realisable value, which is deemed to be their nominal value. No allowance for doubtful accounts is recorded in the balance sheet.

Cash and cash equivalents

They represent the positive balances of bank and postal deposits, cheques, and cash and securities on hand at the close of the financial year. Bank and postal deposits and cheques are valued at their presumed realisable value, cash and cash securities at their nominal value, the details of which are set out in Appendix 2. In this specific case, the realisable value coincides with the nominal value.

Net assets

Net assets include:

- The restricted assets, consisting of the restricted reserves, where funds with a specific purpose not yet used are set aside;
- Free assets, consisting of the results of previous years, as well as other reserves.
- The surplus/deficit for the year.

Accrued income and prepaid expenses

They are calculated on an accrual basis and in accordance with the accrual accounting principle.

Provisions for risks and charges

These consist of provisions set aside to cover losses or debts of a definite nature and of certain or probable existence, but whose amount and/or date of occurrence could not be determined at the balance sheet date.

The general criteria of prudence and accrual were observed in the valuation of these provisions, and no generic risk provisions without economic justification were established.

Contingent liabilities have been recognised in the balance sheet and entered in the provisions as they are considered probable and the amount of the related charge can be reasonably estimated.

Severance pay

This represents the actual debt accrued at the balance sheet date to employees in accordance with the law and labour contracts in force, considering all forms of remuneration of an ongoing nature. The provision corresponds to the total of the individual indemnities accrued in favour of employees at the closing date of the financial statements, net of advances paid, and is equal to the amount that would have been payable to employees if they had terminated their employment on that date.

Debts

Payables are liabilities of a definite nature and certain existence that represent obligations to pay fixed or determinable amounts of cash to lenders, suppliers and other parties. Liabilities are classified on the basis of their nature (or origin) with respect to ordinary operations regardless of the time period within which the liabilities are to be settled.

They are recognised and entered in the balance sheet at their nominal value.

Currency Assets and Liabilities

Assets and liabilities in foreign currencies are measured at the Bank of Italy's exchange rates as on 31 December 2023 published in the Official Gazette General Series No. 7 of 11 January 2024. The related exchange rate gains and losses are charged to the statement of operations.

Management Report

Income and expenses are recognised on an accrual basis and recognised in the income statement according to their nature and correlation.

Taxes

The association is subject to IRAP tax calculated on the value of production, which in our case is indicated by the value of the cost of employees and collaborators. Since there has been no significant change from last year, the tax calculation has settled at the previous values.

4. Movements in fixed assets

Intangible fixed assets

No intangible assets are recorded in the balance sheet.

Tangible fixed assets

Fixed assets are stated at their purchase cost, with the total amount of depreciation in progress shown. Works of art are entered at their estimated realisable value. The value of equipment recorded net of depreciation is 2,623 euros.

Tangible fixed assets include works of art in the amount of 29,700 euros. In accordance with OIC16 Tangible Fixed Assets Paragraph 58, no depreciation has been applied to these assets.

Illustration of the economic and financial performance of the organisation and how it pursues its statutory aims

19. Situation of the entity and management performance

ASIA's priorities during 2023 were food security; developing ecologically sustainable agriculture to combat the effects of climate change; improving access to education; supporting gender equality and the empowerment of women; preventing and preparing the most fragile populations for emergencies; and defending the cultural, spiritual and linguistic heritage of cultural minorities.

Our activities focused on Myanmar and Mongolia and the Himalayan area, Nepal and Bhutan.

The operating performance was positive, but the restricted assets fell sharply from the previous year and were affected by the utilisation of both the previous and current year's restricted funds for the implementation of projects during the year. In addition, 2023 closes with a limited number of approved projects and earmarked funds that will certainly be fully utilised in the course of 2024, creating some doubts about ASIA's sustainability in the coming years.

20. Foreseeable development of operations

In the coming years, unfortunately, due to the serious geopolitical crisis worldwide, the consequences that this crisis is having on the world, European and Italian economies in particular, and, given the cooperation strategies of the current government that have directed all the funds earmarked for cooperation in Africa to the implementation of the so-called 'Piano Mattei', an analysis will have to be made on new sources of funding available through international donors and private foundations.

In addition the development of alternative activities such as the organisation of solidarity trips, e-commerce of handicrafts from projects will be carried out. It will be necessary to increase social capital and launch a campaign on testamentary legacies. Moreover, the organisation will have to review its organisation chart at the Italian headquarters level, trying to reduce costs and create a more efficient and responsive team. In some countries, such as Nepal, it is necessary to find a new legal form that will enable ASIA to cut operating costs due to the obligation to implement projects through local partners and directly access calls for local NGOs.

New impetus must be given to the long-distance sponsorship sector, which has been suffering a continuous decline in recent years but still remains one of the organisation's strategic sectors.

Finally, from the point of view of administrative management, the acquisition of an accounting management module to be inserted in the new database, acquired for the management of adoptions and donations, and to provide software for double-entry cost allocation in the local offices, Nepal and Burma, to speed up accounting and administrative management in general, is necessary.

21. Ways of pursuing statutory goals

From a statute and mission perspective, ASIA can only continue to work on the Asian continent and in particular in the Himalayan region, but it will also have to open up new countries such as Bangladesh or Pakistan, the only Asian countries still included in the Italian cooperation tenders.

In terms of areas of intervention, the priority areas remain education; environmental protection and combating climate change; food security and emergency; and the protection of the heritage, historical, linguistic and spiritual of the Himalayan peoples.

It will be necessary to develop activities in Italy to raise awareness of priority issues for ASIA and organise events to raise funds and acquire new contacts. Finally, it is important to continue to develop global citizenship education projects that enable the dissemination of soft skills in schools such as yoga and awareness towards oneself, the environment and the others, compassion and non-violence.

22. Miscellaneous and Secondary Activities

No other activities of a secondary nature were carried out.

Report on the audit of the financial statements

Judgment

We have carried out the audit of the financial statements of ASIA - Association for International Solidarity in Asia - Third Sector Body (hereinafter also "Body") consisting of the balance sheet as of 31 December 2023 and the management report for the financial year ended on that date and from the sections "General Part" and "Illustration of the budget items included in the mission report.

In our opinion, the financial statements provide a true and fair representation of the equity and financial situation of ASIA - Association for International Solidarity in Asia - Third Sector Entity as of 31 December 2023 and of the economic result for the financial year ended therein given in compliance with the Italian regulations governing the drafting criteria.

Elements underlying the judgment

We have carried out the audit in accordance with international auditing standards (ISA Italia). Our responsibilities under these standards are further described in the paragraph "Responsibilities of the auditor for the audit of the financial statements" of this report. We are independent of the Institution in accordance with the rules and principles relating to ethics and of independence applicable in Italian law to the audit of financial statements. We believe we have acquired sufficient and appropriate audit evidence on which to base our opinion.

Other aspects

The financial statements of ASIA - Association for International Solidarity in Asia - Third Sector Body, for the financial year ending 31 December 2023, are the first to be subjected to statutory audit, as the company has exceeded the limits set out in the art. 31 of Legislative Decree 3 July 2017, n. 117 with reference to the financial years 31 December 2022 and 31 December 2021.

Responsibility of the administrators and the supervisory body of the organization for the financial statements

The directors are responsible for drawing up the financial statements that provide a true and correct representation in compliance with the Italian regulations governing the accounting criteria drafting and, within the terms established by law, for that part of their internal control deemed necessary to allow the preparation of financial statements that do not contain material errors due to fraud or unintentional behavior or events.

The directors are responsible for evaluating the Body's ability to continue to operate as a going concern and, in drafting the financial statements, for the appropriateness of using the going concern assumption, as well as for adequate disclosure in the field. The directors use the assumption of business continuity in the preparation of the financial statements unless they have detected the existence or dissolution and



consequent liquidation of the entity or conditions for the interruption of the activity or have no realistic alternatives to these choices.

The Supervisory Body is responsible for supervising, within the terms established by law, the process of preparing the organisation's financial information.

Responsibility of the auditing firm for the audit of the financial statements

Our objectives are to obtain reasonable assurance that the financial statements as a whole are free from material misstatement, whether due to fraud or unintentional behavior or events, and to issue an auditor's report that includes our opinion. Reasonable assurance means a high level of assurance which, however, does not provide the guarantee that an audit carried out in accordance with international auditing standards (ISA Italia) will always identify a significant error, if one exists. Errors may arise from fraud or from unintentional behavior or events and are considered significant if they, individually or as a whole, can reasonably be expected to be able to influence the economic decisions taken by users on the basis of the financial statements.

When auditing in accordance with International Auditing Standards (ISA Italia), we exercised professional judgment and maintained professional skepticism for the entire duration of the audit. Furthermore:

- We have identified and assessed the risks of significant errors in the financial statements, due to fraud or unintentional behavior or events, we have defined and carried out audit procedures in response to these risks; we have acquired sufficient and appropriate audit evidence on which to base our opinion. With reference to the financial statements closed on 31 December 2023, I supervised the aspects and formalities not related to the statutory audit of the accounts, the setup and its general compliance with the law as regards its formation and structure; in particular I was able to find that the financial statements were drawn up in compliance with the art. 13 of Legislative Decree no. 117 of 3 July 2017 (Third Sector Code) and the Ministerial Decree. 5 March 2020 of the Ministry of Labor and Social Policies, as integrated by OIC n.35 ETS Accounting Principle which governs its preparation.

Furthermore, I have verified the compliance of the financial statements with the facts and information of which I am aware following the performance of my duties and I have no observations in this regard.

On 30 April 2024 I received the document drawn up by the auditing firm Crowe Bompani S.p.a. via email. (Dr. Fabio Sardelli Legal Auditor) appointed by the Assembly of Asia to perform the Legal Audit for the 2023 financial year, which issued the Certification of Asia's 2023 financial statements without qualifications.

Considering that the auditing firm Crowe Bompani S.p.a. has issued its opinion without exceptions, the Monocratic Body finds no impediments regarding the approval of the budget as of 31 December 2023 and of the mission report, expressing a favorable opinion on the proposed allocation of the operating surplus as resolved by the assembly.
